CITY OF ESPAÑOLA ELECTION RESOLUTION 2019-42

BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF ESPANOLA THAT:

- A. A regular municipal election for the election of municipal officers shall be held on March 3, 2020. Polls will open at 7:00 A.M. and close at 7:00 P.M.
- B. At the regular municipal election, persons shall be elected to fill the following elective offices:
 - One Municipal Judge for a four year term.
 - District #1: ONE <u>Councilor</u> for a four year term.

<u>District #2:</u> ONE <u>Councilor</u> for a four year term.

<u>District #3:</u> ONE <u>Councilor</u> for a four year term.

<u>District #4:</u> ONE <u>Councilor</u> for a four year term.

C. Rio Arriba County Precincts 3, 4, 10, 7, 8, 9, 11, 12, 36 and 40 are consolidated for the regular municipal election.

Santa Fe County Precincts <u>1, 58, 59 and 79</u> are consolidated for the regular municipal

The following locations are designated as polling places and Voter Convenience Centers. All residents and qualified electors in the City of Española may vote at the following locations, regardless of where they live in the City:

- Richard Lucero Center located at: 313 North Paseo De Oñate, Española N.M. 87532. (Rio Arriba County)
- McCracken Gym located at: 261 South McCurdy Rd. Espanola N.M. 87532. (Santa Fe County)

Absentee Voting. Applications for absentee ballots may be obtained only from the office of the Municipal Clerk. All applications for an absentee ballot must be completed and accepted by the Municipal Clerk prior to 5:00 p.m., February 27, 2020. After 5:00 p.m. on February 27, 2020, all unused absentee ballots will be publicly destroyed by the Municipal Clerk. The Municipal Clerk will accept completed absentee ballots delivered by mail, or in person by the voter casting the absentee ballot, by a member of the voter's immediate family, or by the caregiver to the voter until 7:00 p.m. on February 28, 2020.

<u>Absentee ballots</u> may be marked in person in the office of the Municipal Clerk during the regular hours and days of business, beginning on Tuesday, January 30, 2020 and closing at 7:00 p.m. on Tuesday, March 3, 2020.

<u>Early Voting.</u> Early voting on paper ballots counted by electronic vote tabulator will be conducted in the office of the Municipal Clerk during the regular hours and days of business, beginning on Tuesday, February 4, 2020 and closing at 5:00 p.m. on Saturday, February 29, 2020.

- E. Persons desiring to register to vote at the regular municipal election must register with the County Clerk of Rio Arriba or Santa Fe County.
- F. All Declarations of Candidacy shall be filed with the Municipal Clerk on Tuesday, January 7, 2020 between the hours of 9:00 A.M. and 5:00 P.M.
- G. The casting of votes by registered qualified electors shall be recorded on paper ballots and be counted by the ICP Vote Tabulators.
